Based on our discussion yesterday, we've revised and prioritized our list of [GH centrally-managed awards/activities](#) and ask that you approve the 16 urgent activities to support lifesaving commodities and services (see lines 3-18). As you requested, additional substantive details on the large Malaria lifesaving commodities activities can be found [here](#).

As discussed, we have deprioritized 42 LHA activities, including those focused on neglected tropical diseases, mpox, polio, and monitoring and surveillance, at this time. Those are marked as priorities other than urgent on the list (but we have not removed them for the list, so that you still have visibility).
